- Maintain an institutional database using a Management Information System (MIS) to support and monitor quality improvement efforts.

- Foster innovative teaching practices and promote the use of e-resources and Learning Management Systems (LMS).
- Conduct Academic and Administrative Audits (AAA) and actively participate in accreditation and ranking processes (e.g., NIRF, NAAC, NBA, and international accreditations).
- Monitor student progress, strengthen mentoring systems, and enhance career guidance and placement services.
- Encourage excellence in academics, research, sports, and extracurricular activities.
- Motivate faculty to publish in reputed international journals and promote entrepreneurship among students.
- Implement robust feedback mechanisms to evaluate faculty, curriculum, institutional performance, and facilities.
- Gather feedback from stakeholders, including parents, alumni, and employers, for continuous improvement.
- Engage students in community service and raise awareness of national issues and responsibilities.
